## Smoothie of the Month



Non-Dairy Blueberry Smoothie Bowl

Start out the day light with a nutritious vegan, gluten-free, paleo breakfast. These delicious blueberry smoothie bowls are really simple to throw together. The frozen banana and soaked cashews make the smoothie extra creamy, but keep it healthy. Recipe courtesy of Loveleaf Co.

### **Ingredients:**

- 1 frozen banana
- 1/2 cup frozen blueberries
- 1/3 cup raw unsalted cashews, soaked overnight or at least 1 hour
- 1 cup unsweetened non-dairy milk, plus more if needed (protein powder can make the smoothie quite thick, so use your judgment).
- 1/4 teaspoon pure vanilla extract
- 1 serving vanilla or unflavored protein powder or collagen peptides
- 2 Medjool dates, pitted (optional, depending on sweetness of protein powder)
- pinch of sea salt
- sliced strawberries and unsweetened coconut flakes, for topping

#### **Instructions:**

- Add all ingredients except the strawberries and coconut flakes to a high-speed blender and blend until smooth and creamy. Add more non-dairy milk depending on desired consistency.
- Divide blueberry smoothie into two bowls. Top with strawberry slices and coconut flakes.
- Serve immediately.
