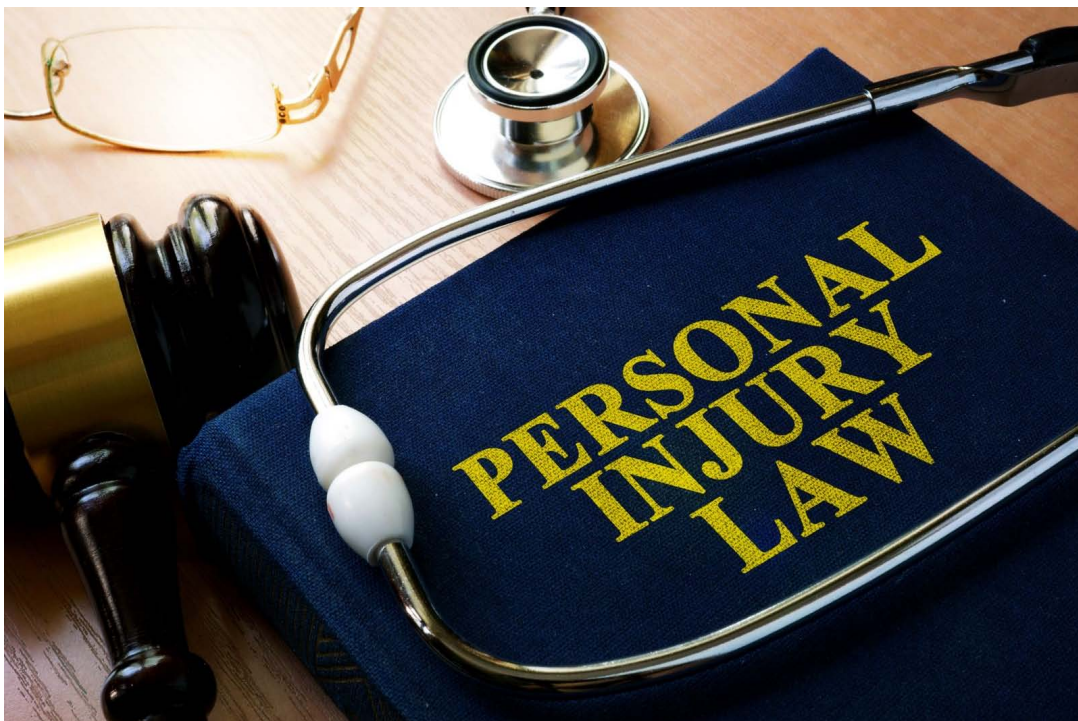
Success Story

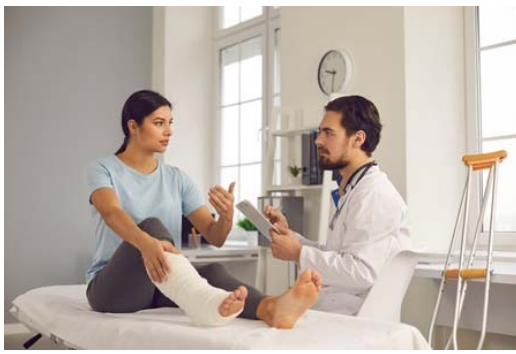
