**Creamy Pumpkin Pie Smoothie (Dairy Free)** 

This creamy and delicious Creamy Pumpkin Pie Smoothie is great anytime of the day, and includes all of the flavors of autumn. It's the perfect fall treat that's Dairy and Gluten Free. <u>Recipe courtesy of Oh She Glows</u>

#### Ingredients:

- 2 cups almond milk
- 1/2 cup rolled oats
- 2 tbsp chia seeds
- 1 cup canned pumpkin
- 1/2 tbsp blackstrap molasses
- 1 frozen ripe banana
- 2 tsp cinnamon
- 1/2 tsp ground ginger
- 1/4 tsp ground nutmeg
- 1.5-2 tbsp pure maple syrup
- Coconut Whipped Cream, for garnish

#### Instructions:

- 1.In a medium-sized bowl whisk together the milk, oats, and chia seeds. Place in fridge for 1 hour or preferably overnight.
- 2.Add soaked oat mixture to blender along with the pumpkin, molasses, frozen banana, and spices. Blend until smooth. Add about 5 ice cubes and blend until ice cold.
- 3.Add maple syrup to taste. I found 1.5 tbsp was perfect for me.
- 4. Serve with Coconut Whipped Cream and a sprinkle of cinnamon on top!
